ORDINANCE OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

Serial No. 2014-35

**An Ordinance Amending the City and Borough Code Relating to
Penalty Classifications and the Traffic and Animal Control Fine
Schedules.**

BE IT ENACTED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

Section 1. Classification. This ordinance is of a general and permanent nature and shall become a part of the City and Borough of Juneau Municipal Code.

Section 2. Amendment to Section. CBJ 01.40.010 Violations penalty, is amended to read:

01.40.010 Violations penalty.

...

(b) *Penalty classifications.*

(1) Except as provided in CBJ 72.10.010 and CBJ 72.10.012, a defendant convicted of a Class A misdemeanor may be sentenced to pay a fine of not more than \$5,000.00, or a definite term of imprisonment of not more than one year, or both.

(2) A defendant convicted of a Class B misdemeanor may be sentenced to pay a fine of not more than \$1,000.00, to a definite term of imprisonment of not more than 90 days, or both.

(3) A defendant convicted of an infraction may be sentenced to pay a fine of not more than ~~\$300.00~~ 500.00.

(4) A misdemeanor not identified as to type or class shall be punishable as a Class B misdemeanor.

Section 3. Amendment to Section. CBJ 03.30.051 Traffic fine schedule, is amended to read:

03.30.051 Traffic fine schedule.

Pursuant to sections 03.30.010—03.30.015 of this chapter, those of the following traffic offenses which are amenable to disposition without court appearance may be disposed of upon payment of the fines listed to the clerk of the court. If a person charged with one of these offenses appears in court and is found guilty, the penalty imposed for the offense may not exceed the fine amount for that offense listed in the following schedule:
