

NOTICE OF UTILITY TARIFF FILING

The REGULATORY COMMISSION OF ALASKA gives notice that Alaska Pacific Environmental Services – Juneau, LLC (APES-Juneau) d/b/a Arrow Refuse has filed tariff revision TA18-653, which seeks to replace standard can services and associated extra waste service with automated and semi-automated roll cart service throughout their service area. The change in basic rates for once weekly residential service is summarized below.

32 Gallon Standard Can Service	\$15.18	Discontinued
48 Gallon Roll-Cart Service	N/A	\$14.45 (\$16.79 in the Blue Zone*)
3 32 Gallon Standard Can Service	\$22.66	Discontinued
96 Gallon Roll-Cart Service	N/A	\$18.61 (\$20.96 in the Blue Zone*)

* The Blue Zone is that area of downtown Juneau that begins at the intersection of Ross Way and Egan Drive and continues southeast to and including Martin Way, bounded by the coastline on the southwest and southern borders and the mountains and Basin Road on the northern and eastern borders.

In addition, APES-Juneau will provide roll-cart cans in either 48- or 96-gallon size for a monthly rental fee of \$3.95. Customers are also permitted to purchase their own cans, providing the purchased cans meet the requirements delineated on proposed Tariff Sheet No. 26, filed with TA18-653. As un-canned bags of trash will no longer be collected, those customers requiring additional cans may rent them from APES-Juneau and pay a single-use fee for the additional can per occurrence.

This notice does not include all proposed revisions. The Commission may approve a rate or classification which varies from that proposed.
