First and foremost we as a group would like to start off by explaining why there are no names taking credit for this correspondence. It is not because we do not wish to expose our names or have someone interview us. Mainly, it is for our protection. Under current state law there is a provision that protects anyone who wishes to report any wrong doing. Alaska Statute 39.25.80 is the statute that affords this right, however, under the current administration within the Alaska Army National Guard there is no protection for anyone who chooses to speak out. Our group consists of more than 10 Soldiers and Airmen from all ranks who want to see changes. We are going to be sending out emails like this one over the next several weeks in the hopes that it will affect change, help the Soldier's that do not have a voice, and the ones that have come forward and nothing has been done.

In our first release we are going to be discussing some issues that have been brought to the attention of Senator Mark Begich, Senator Murkowski, Congressman Don Young, Governor Parnell, State Senator Higgins, National Guard Bureau IG, Department of the Army (DA) IG, and Department of Defense IG. All of these reports of concern have been returned to MG Katkus, BG Bridges, and BG Jorgensen. This would be the normal protocol in these types of cases, however, they are the subject of these reports. They are covering up their actions, and the actions of officers directly under their command authority. On Wednesday 26 March 2014 Gov Parnell publically acknowledged that there are concerns within the AKANG and has asked for a special investigation by NGB. This is long overdue. Hopefully this will add to what is being looked into by the NGB team and brings to light other issues along with how sexual assault cases are being handled in the State.

Part 1 will consist of illegal hiring practices and Equal Opportunity Misconduct.





There are more instances that we can point to where the senior leadership of the AKARNG has failed to do what is right due to either their lack of desire to, fear of reprisals, or their own neglect. We are prepared to send more emails with detailed information about the possible improprieties, names and contact information of witnesses who might be willing to talk if they can be assured that they will not be retaliated against, and something will actually happen to help resolve the issues.

BG Jorgensen is a common name that you will see in almost every complaint that is going to come out when NGB actually gets the truth from Soldiers. Here is a piece of information that most people do not know or understand. She is actively violating assignment policy, promotions, and evaluations. Over the past year there were several LTC's (O5) that were eligible for COL (O6). Instead of promotion based on eligibility, position, or authority she

utilized her position as the Chief of Staff to promote people that support her regime. A COL was moved out of his position on paper only, a LTC was moved into his vacated position. As soon as this took affect the Chief of Staff ensured that his promotion orders were published. Then she moved all of the parties back to their positions. She cited vacancy promotion authority as her reasoning for the promotion because no one was aware of the paperwork shuffle she did. However, due to several key people talking about the moves it came to the attention of several eligible O5. To verify this was actually done you can contact LTC Joseph Lawendowski, MSG John Phlegar, COL Thompson, and CW4 Kostoff. All of these people have personal knowledge that this is an issue and has been reported to DA IG.

Over the past year there have been very public cases involving sexual assault, sexual harassment, or failures by Commands to do what is right for the victims. The AKARNG has not been exempt from this. In 2013 Ret. LTC Kenneth Blaylock wrote a 12 page report detailing numerous allegations concerning the AKANG. Several key leaders were named as either being guilty of illegal sexual conduct, failing to protect victims of sexual assault, or turning a blind eye to accusations because of their connection to the alleged violator. We as a group can attest that there is some truth to what Ret LTC Blaylock wrote and there are even more concerns than he was even aware of. We are not going to release the names of the victims in our emails because this is a private ordeal that they have had to live through. If and when an investigating team comes to Alaska we will ensure that the names of victims and violators makes it to the right people.

The head of the federal National Guard Bureau says the investigation now underway into allegations of sexual assault and harassment within the Alaska National Guard should not be hidden away.

In response to questions from Sen. Lisa Murkowski at a congressional hearing this morning, General Frank Grass said investigators from the Bureau's Office of Complex Investigations are on the case.

"What we've done at the request of the state is sent up an investigation team, about three weeks ago," General Grass said. "We're looking at a broad brush of complaints and we'll do the analysis."

"I'm free to come brief you in more detail on where we're at on that and how much time it might take."

Murkowski accepted the general's offer but says the outcome of the investigation should be transparent to remove the cloud hanging over the Alaska National Guard. Gen. Grass agreed, although he said the report would go to the governor.

Some of the allegations date back as far as 2010.







Please consider this email a formal report of unlawful conduct by members of the Alaska National Guard pursuant to 10 USC 1034 on behalf of



You are hereby advised that should the Alaska National Guard continue to knowingly use the aforementioned confidential criminal justice information, you may be* subject to civil liability damages as allowed by Alaska Statute 12.62.200(a) which reads in relevant part "a person whose criminal justice information has been...used in knowing violation of this chapter or a regulation adopted under this chapter may bring an action for damages in the superior court" (emphasis added).

Continued unlawful disclosure of such documents with regard to AR 15-6 report OR the alleged (who has been clearly identified by name in additional to other confidential/personal information) shall likely be interpreted as knowing and unlawful violation of the law and cause for adverse legal action*.


*As my law licenses do not extend to the state of Alaska, my interpretation of Alaska state law is not as a matter of legal fact, but rather educated legal knowledge.

Consider yourself duly advised of such facts and proceed accordingly with such knowledge.

I, on behalf of hereby demand of you and your Command the following:

- A full audit of personnel who did or could have seen this unlawfully obtained report;
- The removal of the personnel who have seen this unlawfully obtained report from rendering any decision on or being involved in the proposed penalties for the alleged violations contained in the full AR 15-6 investigative findings;
- That the unlawfully obtained report and all copies (physical and digital) shall be immediately returned to the control of a law enforcement officer (due to our intention to initiate litigation with you named as the defendant, I certainly encourage you to consult an attorney prior to destroying any records or deleting any digital copies to prevent the spoliation of evidence); and
- Upon completion of the above, that I receive confirmation that no other unlawfully obtained records exist in the hands of non-Alaska State certified law enforcement personnel.

Furthermore, I am demanding under separate cover that MG Katkus conduct an AR 15-6 investigation into your conduct, CPT Vanison's conduct/performance, and determine how confidential law enforcement information about an alleged was obtained by a 'weekend warrior' outside the scope of his employment/investigative authority. Given the serious nature of these allegations, the need for a complex investigation and the impact it could have on trust in local law enforcement reporting (ie any weekend warrior can walk in and learn the most intimidate details of their sex lifes with nothing more than an 'appointment order' that doesn't even allow access to civilian police files or pertain to misconduct involving civilians and have those details freely and widely distributed in National Guard circles), I am under separate cover filing a report of misconduct/unlawful activities with the Inspector General.



I hereby call on your immediate resignation as the Brigade Commander. If you do not resign your Command, I will exercise my rights under the 1st Amendment to publicly call upon the Commander in Chief of the Alaska National Guard to relieve you for cause. By separate communication to the Alaska Attorney General, I am placing them on notice of our intent to commence a 42 USC 1983 action against you in your personal capacity as well as every other individual who knew or should have known that obtaining, possessing, and distributing of confidential civilian sexual assault victim information in this case was not in accordance with the rights afforded under the United States Constitution and applicable law, rules, and regulations or even covered by your appointment orders/competent lawful authority.

In all my years in the military and as a civilian military criminal defense attorney, I have never been so disturbed by the deliberate indifference and lack of common sense by so many in one command.

I will also inform you that this is only the first in a series of allegations of misconduct that we will disclose in due course. As the saying goes this isn't the strongest, best, or most powerful arrow in our quiver just merely the first one in which we will use but be assured that this is the 'tip of the iceberg' of 10 USC 1034 reporting. It is merely being disclosed first/quickly to mitigate damages and place you and others on 'notice' per AS 12.62.200(a).
