attest to the following and state:

On 12/31/2019 [redacted] called 911 to report a structure fire at 8365 North Tongass Highway. Fire Departments from North Tongass, South Tongass and Ketchikan City responded and extinguished the fire which was isolated to the car port area of the property.

AST contacted the homeowner David [redacted] who said his former girlfriend Kami D. Riley had been banging on his door at 2am this morning but he didn't open the door. David said Kami was with an unknown man. David reports receiving a voice mail from Kami at 0153 hours from a number 617-[redacted], later verified to be the assigned cell phone for AST Trooper Joey Beaudoin. In the voicemail a female voice can be heard saying "we are the FBI and are going to burn your house down".

David [redacted] told me that after waking up later this morning he saw Kami walking on the highway & hitchhiking just minutes before he detected smoke coming from his property. [redacted] went outside to find a black plastic container and the carport both fully engulfed with flames. [redacted] said a passerby ([redacted]) had already stopped and called 911 to report the fire.

At 0726 hours [redacted] called AST to report he had picked up a female hitchhiker in the area close by the fire and drove her to town. During an interview with [redacted], he told AST that he saw flames coming from the carport when he stopped to pick up Kami. He said her clothing smelled of diesel fuel and he dropped her off at Safeway. [redacted] said during the ride to town he asked Kami about the fire and she told him "that guy got what he deserved." [redacted] said he became uncomfortable with Kami's statements and during small talk she told him her name was Kami Dawn Riley and that she was originally from Denver. [redacted] called AST immediately after dropping Kami off at the Safeway store. USFS Officer Thompson located Kami Riley at a bus stop near Safeway, she was detained and transported to the AST post. Officer Thompson relayed to AST that Kami's clothing smelled heavily of heating fuel or diesel.

After arriving at the AST post Trooper Kimura read Kami the Miranda Rights and Walver to which she understood and agreed to answer questions related to the fire. During questioning by Sgt. Webb Kami affirmed that she was brought out to the [REDACTED] house this morning by a trooper and that she was banging on the door but [REDACTED] wouldn't come to the door. Kami said she slept in [REDACTED]'s truck, drank a beer and left. She claimed no knowledge of the fire. During an interview with Ketchikan City Fire Marshall Andrea Buchanan Kami stated she saw the smoke before departing [REDACTED]'s residence today but didn't know anything about the fire.
