#### For Immediate Release

This brief provides an update on information from the Emergency Operations Center (EOC) and its partner agencies.

#### **COVID-19 Case Count Update**

There were no additional cases of COVID-19 reported in Ketchikan today. The total number of positive cases of COVID-19 in Ketchikan remains at sixteen (16). Of these cases, two (2) individuals had a recent history of travel, and thirteen (13) individuals were identified as having been in close contact with an individual diagnosed with COVID-19.



#### Gateway Recreation Center Use as Emergency Homeless Shelter Scheduled to End May 3

With the changes in the Governor's Health Mandates, the EOC has determined that the Homeless Shelter operated at the Recreation Center can close. As of Sunday, May 3rd, shelter operations will cease at the center. First City Homeless Services will reopen its day shelter at the Methodist Church. The EOC will begin the cleaning of the Recreation Center on May 4th to include removal of equipment, furniture and floor coverings, and will perform pest control and disinfection treatments. Following the cleaning, Borough staff will be transitioned back to the Recreation Center to prepare the facility for operations within the constraints of the Governor's Health and Economic Recovery Mandates. The goal is to have the center available for operations by Memorial Day weekend or sooner.

#### Updates to Health Mandates to Reopen Alaska's Economy

Governor Dunleavy, with Dr. Anne Zink, and DHSS Commissioner Crum, have announced the *Reopen Alaska Responsibly Plan* effective Friday, April 24<sup>th</sup>.

In addition to Health Mandate 16 released on April 22, the following announcements were made during the Governor's press conference tonight to be effective on April 24th:

- Households may engage in outdoor activities in family groups of less than 20.
- Fishing charters can resume for single household unit or up to 25% capacity of mixed units.
- Gyms can resume for outdoor activities of groups less than 20 with social distancing.
- Campgrounds are opened with social distancing in place.
- Alaskans are encouraged to "get out and see Alaska."
- Childcare and daycamps will be allowed.

New information is expected to be provided on the website on April 24<sup>th</sup> for fishing charters, religious services, childcare, gyms, and remote lodges.

## Health Mandate 17 – Protective Measures for Independent Commercial Fishing Vessels

This mandate was announced tonight, effective April 24<sup>th</sup>, and placed on the health mandate website. The purpose of this Mandate is to enact protective measures for independent commercial fishing vessels operating within Alaskan waters and ports in order to prevent, slow, and otherwise disrupt the spread of the virus that causes COVID-19. The mandate requires protective measures and plans, and includes two appendices:

- 1. The Alaska Protective Plan for Commercial Fishing Vessels
- 2. Mandate 17 Acknowledgement Form

We encourage business owners to read the full texts of the revised mandates and ensure that your business can fully comply with the mandates prior to opening.
