COUNT I:

That in the First Judicial District, State of Alaska, on or about September 21, 2022, at or near Juneau, ANTHONY MICHAEL MIGLIACCIO intentionally caused the death of another person, namely Faith Rogers.

All of which is a class U Felony offense being contrary to and in violation of AS11.41.100(a)(1)(A) and against the peace and dignity of the State of Alaska.

COUNT II:

That in the First Judicial District, State of Alaska, on or about September 21, 2022, at or near Juneau, ANTHONY MICHAEL MIGLIACCIO, with intent to cause serious physical injury to another person or knowing that the conduct was substantially certain to cause death or serious physical injury to another person, caused the death of any person, namely Faith Rogers.

All of which is a class U Felony offense being contrary to and in violation of AS11.41.110(a)(1) and against the peace and dignity of the State of Alaska.

COUNT III:

That in the First Judicial District, State of Alaska, on or about September 21, 2022, at or near Juneau, ANTHONY MICHAEL MIGLIACCIO knowingly engaged in conduct that resulted in the death of another person, namely Faith Rogers, under circumstances manifesting an extreme indifference to the value of human life.

All of which is a class U Felony offense being contrary to and in violation of AS11.41.110(a)(2) and against the peace and dignity of the State of Alaska.

COUNT IV:

That in the First Judicial District, State of Alaska, on or about September 21, 2022, at or near Juneau, ANTHONY MICHAEL MIGLIACCIO recklessly caused the death of another person, namely Faith Rogers.
