



ALTERNATIVE 5 WELCOME CENTER FLOOR PLAN







FIRST FLOOR PLAN










ALTERNATIVE 7 **RESTROOM &** KIOSK FLOOR PLAN






Steep creek pedestrian crosswalk and wildlife underpass at Glacier Spur Road




Creek section with proposed trail overlook




